#### Directions for Use

<b>WHERE TO USE:</b>	GRN Sward can be used on all major turf species in all areas including but not limited to golf course putting greens, tees, fairways, roughs, and athletic fields.
<b>RATES:</b>	<b>SPRAY:</b> 1-2 fl oz/ 1,000 ft <sup>2</sup> or 44 – 88 fl oz/ acre every 7-14 days (double rates for 14–28-day applications if desired) Deliver desired rate in a minimum of 1-2 gal/1,000 sq ft spray volume.
<b>APPLICATION TIMING:</b>	GRN Sward can be used all growing season.

Fill the mixing tank with half of the required water volume and begin agitation. Products should be added in the order of adjuvants, pesticides, fertilizers and then surfactants, mixing thoroughly after each addition. Fill tank with remainder of water and continue agitation until solution is completely mixed. Spray out completely, and properly clean equipment. Do not store mixture in spray tank overnight. Always be mindful of mixing high and low pH products (see SDS), check chemical mixture compatibility using a jar test prior to application. It is the responsibility of the end user to ensure compatibility and safety of tank mixes.

#### FOR MD, PA AND VA:

Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn, and sweep any product that lands on the driveway, sidewalk or street back onto your lawn. For professional use only.
