## Directions for Use

### WHERE TO USE:

CarbN with UniGrow can be used on all major turf species in all areas including but not limited to golf course putting greens, tees, fairways, roughs, and athletic fields.

### APPLICATION:

10 oz/1,000 sq ft of CarbN with UniGrow contains  $\frac{1}{8}$  lb of nitrogen.  
Deliver desired rate in a minimum of 1 gal/1,000 sq ft spray volume.  
Apply as needed during the growing season.

## WHEN USING CARBN WITH UNIGROW AT HIGH RATES DURING TIMES OF MOISTURE AND HEAT STRESS, WATER IN IMMEDIATELY AFTER APPLICATION.

Compatible with most chemicals and other fertilizers. Once agitated and mixed in tank with other fertilizers and chemicals, spray out completely. Do not store overnight in spray tank.
