6. ACCIDENTAL RELEASE MEASURES

In Case of Spill: Evacuate the spill area, except for cleanup personnel. Wear personal protective equipment (PPE). Control spill with adsorbent pads or booms. Recover free liquid. Precautions to be Taken in Storage: Product should be stored in a dry place. Do not store together with food, beverage and animal feed.

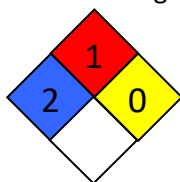
