**General Use Guidelines**

**INITIAL APPLICATION:** **IMPORTANT:** Begin applications at least one month prior to the onset of stress conditions. Under high stress situations such as presence of localized dry spot (LDS), above average growing degree day (GDD) and/or low rainfall, an application of **Aqueduct®** should be conventionally applied to problem areas 7 days prior to the first application of Dispatch Injectable.

**Directions for Use**

**WHAT IT DOES:** Dispatch Injectable improves the infiltration and penetration of applied irrigation water and rainfall. Improvements in moisture content are most notable during periods of moisture stress.

**WHERE TO USE:** Dispatch Injectable is recommended for use on fine turfgrasses such as those found on golf courses, athletic fields, residential and commercial and other highly maintained turf areas.

Inject **12-24 fl oz/acre** (1-2 L per hectare) on a weekly basis. For more difficult areas, Dispatch Injectable may be applied at **48 fl oz/acre** (3.6 L per hectare).

**APPLICATION RATES AND FREQUENCY OPTIONS\*:** Variables which impact performance and program application can be: soil type, turf type, presence of LDS (localized dry spot), quality of irrigation water, growing degree days (GDD), and rainfall intervals.

For application by conventional spray rig equipment, use **Dispatch Sprayable**.

\*Recommendations assume **season long** program applications.
