General Use Guidelines

INITIAL APPLICATION:

IMPORTANT: Begin applications at least one month prior to the onset of stress conditions. Under high stress situations, such as presence of localized dry spot (LDS), above average growing degree day (GDD), and/or low rainfall, an application of Aquedot® should be conventionally applied to problem areas 7 days prior to the first application of Dispatch Sprayable.

Directions for Use

WHAT IT DOES: Dispatch Sprayable improves the infiltration and penetration of applied irrigation water and rainfall.

WHERE TO USE:

Dispatch Sprayable is recommended for use on turfgrasses such as those found on golf courses, athletic fields, residential and commercial turf areas.

APPLICATION RATES AND FREQUENCY OPTIONS*:

Interval	Rate oz/A	Rate L/Ha
2 weeks	16 oz	1.17L
3 weeks	24 oz	1.75L
4 weeks	32 oz	2.34L

Dispatch Sprayable does not need to be watered in following application. Irrigate before next mowing or leave baskets off. Dispatch Sprayable is formulated to be applied by conventional spray rig equipment. For injection through irrigation systems, use **Dispatch Injectable**.

TANK MIXING:

For improved delivery of some fertilizers, apply 16 ounces per acre (1.16 liters per hectare). Dispatch Sprayable is compatible with most turf chemicals. Prior to application, a jar test should be performed to evaluate the tank mix for compatibility and applied to a small area to determine the effect on turf quality.

Precautionary Statements/First Aid Measures in Case of Contact
