### GENERAL INFORMATION

VIVAX 10G is a combination of surfactants that increase volumetric water content and improve water infiltration across a wide range of soils and turf types. Its improved environmental profile and granular formulation make VIVAX 10G suitable for use on all golf courses, athletic fields and residential or commercial turf.

### DIRECTIONS FOR USE

To achieve the best results, apply VIVAX 10G using the application techniques described below.

VIVAX 10G can be applied at any time of the year, using conventional fertilizer spreaders. VIVAX 10G can be applied prior to the onset of turf stress or as a curative treatment later in the growing season.

### APPLICATION TECHNIQUES

Apply to dry turf only. Following the application, irrigate with enough water to remove the active ingredient from the carrier and move it into the root zone. VIVAX 10G granules may be picked up by reel mowers. To prevent mower pickup, remove mower baskets until the granules have been exposed to a full irrigation cycle.

### USE RATES

Apply 3.5 lbs. (1.587 kg) per 1000 square feet (92.9 m<sup>2</sup>) on 30 day intervals to relieve the symptoms of LDS.

### SPREADER SETTINGS

Spreader settings are recommendations only and should be considered as a starting point from which to calibrate the spreader. Results may vary based on equipment, application techniques and environmental variables beyond the manufacturer's control. Spreaders should be calibrated prior to making the initial application of VIVAX 10G and recalibrated prior to subsequent applications.
