#### DIRECTIONS FOR USE

**WHERE TO USE:** Base Micro is designed for year-round application to all managed sports and amenity turf including golf courses, stadium and sports pitches, bowling greens, tennis courts and cricket grounds.

**APPLICATION RATE:** Apply 0.75-1.5 L/ha, in a maximum of 200-600 L/ha water.

**APPLICATION TIMING:** JAN FEB MAR APR MAY JUN JUL AUG SEP OCT NOV DEC

To maximise foliar uptake, avoid spraying in high temperatures. Avoid applications in frost or drought. Base Micro is tank-mixable with other products from the range. It can be tank-mixed with all Aquatrols soil surfactant products.

#### Storage and Disposal

Base Micro should be stored in a cool dry place, out of direct sunlight. To maintain product quality, storage temperatures should be between 50°F and 90°F. Always store liquid products on lower shelves and dry products on higher shelves. Do not stack palletized products. **Open containers must be resealed for storage.** Strictly adhering to Aquatrols storage guidelines will ensure efficacy and performance for the life of the product.
