## DIRECTIONS FOR USE

<b>WHERE TO USE:</b>	Base N is designed for year-round application to all managed sports and amenity turf including golf courses, stadium and sports pitches, bowling greens, tennis courts and cricket grounds.
<b>APPLICATION RATE:</b>	Apply 10 - 50 L/ha, in 400 - 600 L of water.
<b>APPLICATION TIMING:</b>	JAN FEB MAR APR MAY JUN JUL AUG SEP OCT NOV DEC

To maximise foliar uptake, avoid spraying in high temperatures. Avoid applications in frost or drought. Base N is tank-mixable with other products from the range. It can be tank-mixed with all Aquatrols soil surfactant products.

## Storage and Disposal

Base N should be stored in a cool dry place, out of direct sunlight. To maintain product quality, storage temperatures should be between **50°F** and **90°F**. Always store liquid products on lower shelves and dry products on higher shelves. Do not stack palletized products. **Open containers must be resealed for storage.** Strictly adhering to Aquatrols storage guidelines will ensure efficacy and performance for the life of the product.
