DIRECTIONS FOR USE

WHERE TO USE:	Ferrosol Pro is designed for year-round application to all managed sports and amenity turf including golf courses, stadium and sports pitches, bowling greens, tennis courts and cricket grounds.
APPLICATION RATE:	Apply 20 L/ha for green up and winter hardening in 800 L of water.
APPLICATION TIMING:	JAN FEB MAR APR MAY JUN JUL AUG SEP OCT NOV DEC

For best results, apply to growing turf or plants. Provides excellent results for 4 weeks or more when used at recommended rates. Results may vary depending on level of fertility and existing environmental conditions. Ferrosol Pro is tank-mixable with other products from the range. It can be tank-mixed with all Aquatrols soil surfactant products. Avoid spraying in the heat of the day. Avoid applications during frost or drought. This product contains urea which can release ammonia and have an impact on air quality. Depending on local conditions appropriate remediation measures must be taken.

Storage and Disposal

Ferrosol Pro should be stored in a cool dry place, out of direct sunlight. To maintain product quality, storage temperatures should be between **50°F and 90°F**. Always store liquid products on lower shelves and dry products on higher shelves.
